**RE: Call for Nomination of Officer

Dear Member,

As you will recall, a change in the by-laws was recommended by the Board. A ballot was sent out and at the Spring Board meeting held in Denver, CO, on April 16, 2010, those ballots were counted. The motion to change the by-laws was passed unanimously. One of the changes involved the configuration of officers on the Board. The position of 2nd Vice President was eliminated and replaced by the Immediate Past President position to provide for continuity on the Board. This is the year we elect new officers to the Board. As a result of the by-law change, there will only be four positions up for election: President, Vice President, Secretary and Treasurer.

This letter is the official call for nomination for the above-noted positions. Attached you will find a list of the positions and the duties of each. You will also find a nomination form. Nominees must be members in good standing with Western Correctional Association. Basically, that means that membership dues must be current. If you or your nominee has forgotten to renew, here is your chance! A membership form is also attached.

It will be a benefit to the entire membership to have a good selection of nominees to vote for at election time, so please send in those nominations. If you would like to run for an office, GREAT! You can nominate yourself! Volunteers are always especially welcome. Please note on the form that the potential nominee must agree to run for the office. Nominations must be received by the Secretary no later than May 29, 2010.

This letter is also a call for nomination for awards. Attached you will find a description of the awards and a nomination form. Award nomination forms must be received by June 15, 2010.

Information on where to send nominations for officers and for awards is on each nomination form. Feel free to copy the forms and nominate for more than one office or category.

Western Correctional Association is delighted to be a co-host the 2010 conference with Utah. The dates are August 5-6, 2010. The awards will be given, and the election ballots will be counted with the new officers installed at the conference. It would be great if anyone nominated for an office be present at the conference for the installation of new officers. The location has not been set, but this information and other conference updates will be following in the Newsletter which should be out before the end of May.
